IRVINE HIGH SCHOOL PARKING REGULATIONS

THE FOLLOWING PARKING REGULATIONS MUST BE OBSERVED OR ONE OF THE FOLLOWING CONSEQUENCES WILL OCCUR:

- a) Removal of Parking Permit
 - b) Citation Issued by Irvine Police Department
 - c) Vehicle towed at owner's expense
1. STUDENTS ARE ONLY ALLOWED TO PARK THEIR VEHICLE IN STUDENT DESIGNATED SPACES WITH A CURRENT VALID I H S PARKING PERMIT ON THEIR VEHICLE.
 2. Vehicles must only take one space.
 3. Students CANNOT park up on the inner campus.
 4. Students CANNOT park in staff designated, 30 min., handicapped spaces or in the Fire Lane. **If you park in the spaces listed above, your parking permit will be revoked.**
 5. Only one parking permit per student will be issued. If you sell your vehicle or replace your windshield, you must remove the old permit (in pieces if necessary) and return it to Mr. Meader's office to acquire a replacement. If you acquire a new vehicle, a new card will need to be completed with the current information. There is a \$5.00 charge for any replacement sticker.
 6. If your car is temporarily out of service, you may be issued a temporary permit.
 7. All traffic/vehicle laws must be observed while on the premises or surrounding areas of Irvine High School.
 8. Any attendance/truancy problems (10 abs. or more), including TA, suspension or assigned detentions, may result in removal of your parking permit.
 9. An I H S staff member will affix the permanent parking sticker to your inside front window lower right side. **PARKING PERMITS CANNOT ABE REMOVED, ALTERED OR TRANSFERRED TO ANOTHER VEHICLE OR LOCATION** (exception is when turning it in for a new one).
 10. No smoking is allowed in vehicles, on school property or surrounding areas, which include Escolar, front and rear parking lots.
 11. Defiance of authority towards a school employee or peace officer may result in removal of parking permit and privileges.
 12. Any form of reckless driving, speeding, burning out, sitting on a vehicle in motion, or excessive loud music may result in parking privileges being revoked.
 13. There will be a charge of \$5.00 for your parking sticker and for all replacement stickers.

Irvine High Parents and Students:

The Irvine Police Department will again provide daily parking enforcement at the high school. The Police Department will work closely with the school to insure strict adherence to all parking laws and regulations. **Violation of any of the IRVINE HIGH SCHOOL PARKING REGULATIONS (listed on the back of the IHS STUDENT PARKING PERMIT APPLICATION "blue card") may result in a citation.**

Students who are granted parking permits must display them inside the lower right side of the front windshield. The Campus Control Officers will place the permits on the vehicle. The parking permits are nontransferable. Parking permits are issued to a specific vehicle and cannot be placed onto another car. Misuse of the permit can result in a citation and/or confiscation of the parking permit.

A citation is against the registered owner of the vehicle. If it is not paid on time, the fine(s) increase and the Department of Motor Vehicles (DMV) will place a registration hold on the vehicle. Any vehicle that has over five outstanding citations can be impounded.
